
# **Emissions reduction targets**

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets.

We project that carbon emissions will decrease over the next five years to 2.75 tCO<sub>2</sub>e by 2030. This is a reduction of 25%

## Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2025 baseline. The carbon emission reduction achieved by these schemes equate to 8.7 tCO<sub>2</sub>e, a 153%ge reduction against the 2025 baseline and the measures will be in effect when performing the contract

- Many staff work at home more routinely, and we have reduced our number of desks in our shared office space from five to four.
- We hold many more internal and client meetings online, resulting in a reduction in business travel, hotel nights and employee commuting.
   We know that there is still time needed to determine a true future steady state, but our estimates are that we will have reduced carbon use. Disregarding the impact of future business growth creating an increase in the quantum of activity, we consider that these changes are sustainable.
- We are implementing an ISO14001 certification scheme in November 2025.
- We have reduced the amount of flights and opten in for more sustainable travel such as trains.
- We have partnered with Evertreen who will plant 100 trees a month and a further 500 for every project we complete that's 6,000+

annually. Evertreen's philosophy is for trees to be planted by those who need it most and where they are most useful from an environmental point of view. Evertreen operate globally through projects in Nepal, Mozambique, Madagascar, Kenya, Indonesia, Haiti, Honduras and Nicaragua and distinguishes itself for financing local farmers around the world. In 2025, our trees have absorbed 8.7 tCO<sub>2</sub>e.

#### **Future carbon reduction initiatives**

In the future we hope to implement further measures such as:

- We offer an employee bicycle purchase scheme to help make it
  possible for employees to cycle to the office. This is in a context
  where we have carried out several assignments for clients about
  promoting green skills at local level. This has created a lot of interest
  among our staff in the carbon reduction agenda and we regularly
  exchange ideas about business and personal contributions to carbon
  reduction in our team meetings.
- In our periodic review meetings with our landlord, we encourage them to make lower carbon improvements to the office environment.

### **Declaration and Sign Off**
